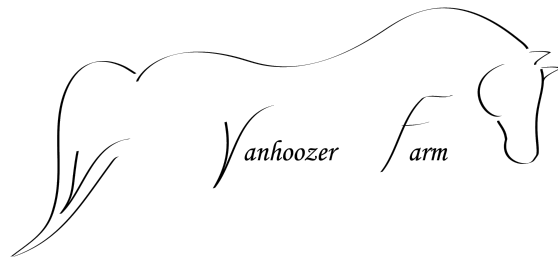

RELEASE AND WAIVER OF LIABILITY

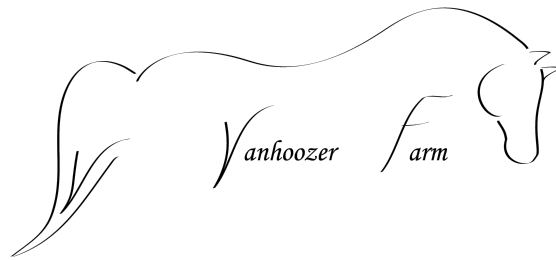
I, _____, hereby agree to the following provisions, and acknowledge the receipt of this agreement in full. I understand that my signature affirms this on behalf of myself (and/or my minor child), _____.

In consideration for allowing me (or my minor child) to handle and ride a horse or on behalf of myself, my child, or our personal representatives, heirs, next-of-kin, spouses and assignees, I hereby agree to the following, as indicated by my initial next to each item:

1. Understand that UNDER TEXAS LAW (CHAPTER 87, CIVIL PRACTICE AND REMEDIES CODE), AN EQUINE PROFESSIONAL IS NOT LIABLE FOR AN INJURY TO OR THE DEATH OF A PARTICIPANT IN EQUINE ACTIVITIES RESULTING FROM THE INHERENT RISKS OF EQUINE ACTIVITIES.
2. ACKNOWLEDGE THAT HORSEBACK RIDING IS AN INHERENTLY DANGEROUS ACTIVITY AND INVOLVES RISKS THAT MAY CAUSE SERIOUS INJURY AND IN SOME CASES DEATH, because of the unpredictable nature and irrational behavior of horses, regardless of the extent of their training and past performance.



3. Voluntarily assume all of the risk and danger of injury or death inherent in the handling or riding of the horse, and use of saddles, bridles, equipment and gear provided by the Releasee(s).
4. Release, discharge and promise not to sue the Releasees for any loss, damage, injury (including death) or cost to me or my child's person or property arising out of riding or handling a horse, or use of saddles, bridles, equipment or gear provided by Releasees.
5. Release the Releasees from any claim that the Releasees were negligent in connection with my or my child riding a horse, including but not limited to, training or selecting horses, maintenance, care, fit or adjusting of saddles or bridles, instruction on riding skills or leading and supervising riders, which results in loss, damage, injury or death.
6. Expressly agree that the foregoing release and assumption of risk, and indemnity agreement is governed by the laws of the State of Texas and is intended to be as broad and inclusive as is permitted by Texas law, and that in the event any portion of this Agreement is determined to be invalid or unenforceable for any reason, the balance of the Agreement shall not be affected or impaired in any way and shall continue in full legal force and effect.
7. Acknowledge that this document is a contract and agree that if a lawsuit is filed against the Releasees for any injury or damage in breach of this contract, I will pay all attorney fees and costs incurred by the Releasees in defending such an action.
8. Acknowledge and accept that IT IS REQUIRED THAT ANY RIDER UNDER THE AGE OF 18 MUST WEAR A PROTECTIVE HELMET PRIOR TO HANDLING OR RIDING ANY HORSE. I UNDERSTAND THAT IT IS MY FULL RESPONSIBILTiy TO ENSURE THAT MY CHILD HAVE THE APPROPRIATE PROTECTIVE HELMET AND THAT IT IS WORN RESPONSIBLY AND APPROPRIATELY AT ALL TIMES.
9. It is recommended that all riders wear a protective helmet while riding horseback. It is my understanding that a protective helmet is available and has been offered for my safety. By signing below, I acknowledge the increased risks of not wearing a helmet.
10. If the person who is to enter into this Agreement is under eighteen (18) years of age, his/her parent or guardian must read this Agreement and sign below on behalf of the minor child.



I hereby, intending to be legally bound, for myself, my heirs and assigns, executors or administrators, waive and release forever all claims for damages against Vanhoozer Farm, instructors, aides, volunteers and/or Larry and Barbara Vanhoozer, Katelyn Vanhoozer, and Kristi Breickler d/b/a Vanhoozer Farm; horse owners; for any and all injuries and/or losses I/my son/my daughter/my ward may sustain while participating in Vanhoozer Farm horseback riding program.

I HAVE READ THIS DOCUMENT. I UNDERSTAND IT IS A LEGALLY BINDING DOCUMENT THAT RELEASES THE AFOREMENTIONED RELEASEES OF ALL CLAIMS. I HAVE MADE A FREE AND DELIBERATE CHOICE TO SIGN THIS RELEASE AND WAIVER AS A CONDITION TO RELEASEES ALLOWING ME OR MY CHILD TO RIDE OR HANDLE A HORSE. I HEREBY ACKNOWLEDGE THAT I UNDERSTAND THE RISKS INVOLVED IN HANDLING AND RIDING HORSES, AND THAT THIS IS A FULL RELEASE AND WAIVER OF LAIBILITY.
